EXPULSION HEARING

Present: School Board Chair Ginger Littleton; School Board Vice Chair Steve Moss; School Board Member Jerry Register; Sarah Whaler, Coordinator of Student Placement Options and Attorney Franklin Harrison.

Attorney Franklin Harrison called the Expulsion Hearing to order at 9:07 A.M.

 Merritt Brown Middle School student – N.A. Case #1819004

The student's parents were present for the hearing which they requested to be held in private. The student was charged with Disruption on Campus Major (ie Bomb Threat/ False Alarm) SESIR. Sworn testimony was given by Charlotte Marshall, Principal of Merritt Brown Middle School, Judy Frye, Assistant Principal, Merritt Brown Middle School, Edward Turner, BCSO Investigator, and the student's parents.

Motion by Register, seconded by Moss, to accept the Superintendent's recommendation (that the student be expelled for the remainder of the 2018-19 school year, including summer school, and all of the 2019-2020 school year, including summer school, and not be offered alternative placement during the expulsion period). Motion was unanimously approved.

The expulsion hearing concluded at 9:40 a.m.

The minutes were unanimously approved.

At this time, Ginger Littleton asked Sharon Michalik, Director of Communications, to update the Board on the donations flooding into the warehouse for the students and the schools. The Board Members shared their experiences with Hurricane Michael.

Janet Kessler spoke about the donations to the BDS Rebuild Program. The Classroom Grants were suspended to redistribute the \$160,000 grant money to classroom supplies and to fund need supplies that aren't donated. Mentoring and Take Stock programs will restart in January.

Walker stated that athletics helps student to focus and self-discipline.

Littleton spoke about the difficult decisions that have to be made.

Moss shared that the seniors are adapting and Senior Night will be at the Arnold's Girls Soccer match. Flexible is the new word! He thanked Mr. Walker for serving with him and Mrs. Littleton for serving 2 years as Chair.

A. Superintendent

Emergency Item – Land Use Agreement

The Superintendent shared that this is an agreement for the Arnold High School students to park on the Emerald Coast Resort, LLC. Property while the students attend Surfside Middle School temporarily.

Motion by Register, seconded by Walker, to include this on the agenda as an emergency item due to the lack of the required 48 hour notice. Motion unanimously approved.

Motion by Register, seconded by Moss, to approve. Motion unanimously approved.

1. Request Approval of Emergency Expenditures (SMF #3)

Pulled to Action by Moss

Moss questioned if the modular classrooms in this request were in addition to the previous modulars approved. Lee Walters explained that he will only order as needed and return them as soon as possible. There will be a 1 year lease on these modulars. The Superintendent stated that the lease should be reimbursable expense from FEMA.

Motion by Register, seconded by Moss, to approve. Motion unanimously approved.

A. School Board Members and Attorney

This request is to add additional services as required to prepare the schools for reopening. Once the schools open, the list will be removed per the Superintendent.

Motion by Moss, seconded by Register, to approve. Motion unanimously approved.

2. Request to Cancel the Florida Department of Health Memorandum of Understanding (SMF #14)

The Superintendent is requesting to cancel this Memorandum of Understanding due to the disruption it has created in the schools. Heather Hudson explained that this agreement was approved in September but that it resulted in several nurses in the school offices reviewing records. PanCare is currently providing the majority of the services and the District is reworking the School Health Services Plan with the Florida Department of Health which would capture all the services. Moss asked how this would impact the students and Hudson replied that there would be no negative impact.

Register reported that he has researched this in length. He shared his experience with the Health Department as a child and as a Principal. He spoke about the issue with media reports of nurses removing student records. He invited Mandi Chesser, Supervisor of School Health, to speak. She stated Florida Statutes requires that the Health Department has role in auditing records, student health, and student health and would not compromise the health of the students. She said no records were taken from the schools. The Superintendent stated that the records are missing and he is responsible for student records. The records are not the property of the Department of Health.

Motion by Moss, with lack of a second, Littleton passed the gavel and seconded the motion to approve. Motion did not pass with Register and Walker voting no.
