F. Kiwanis Club Reading Oasis Presentation

Eric Krebs announced The Kiwanis Club of Panama City's partnership with Scholastic Books and the Florida Kiwanis Foundation to create a Reading Oasis in 6 area elementary schools: Cherry Street, Springfield, Lucille Moore, Patterson, Oakland Terrace and Cedar Grove. C. Bay Education Foundation

Janet Kessler, Executive Director, shared that the Foundation has funded 47 graduating senior scholarships. On May 23rd, they will induct 26 new 7th and 8th graders into the Take Stock in Children Program.

D. Citizens Oversight Committee

Bob Miller, Chairman, reported on the April 17, 2018 meeting of the Citizens Oversight Committee. He shared that the committee reviews every invoice that uses funds from the half cent sales tax. The needs of 38 schools, technology & security needs, and the budget cuts make it necessary to have this funding in place. Currently, \$20 million comes into the district from this tax which 40% is paid by tourists to the area. This tax has saved over \$50 million in ad vol. taxes. He feels that better schools produce better students, better students produce better adults and better adults produce a better community to thrive and grow.

Superintendent Husfelt shared that Principal Todd Harless said that CC Washington has made 400 credits in 3 years and discipline has decreased to 1 referral a day. Katie McCurdy did a fantastic job with the State Science Fair Team. The summer Driver's Ed Program had 550 students register for 250 spots in the program. After reviewing the registrations, one student registered 112 times. He spoke about the community support and appreciates all that they do for the students.
