Note 1: CDW-G proposed alternative equipment at apparent lower cost. Currently, we have several Extreme network devices in use, and our past experiences have shown significant challenges with their products. These include difficulties in programming, configuring, and managing their equipment, as well as concerns about the ongoing costs associated with their complicated and expensive licensing model. Licensing model includes purchasing annual licenses per item which significantly increase the cost of the proposal. Additionally, the centralized control offered by Extreme products does not align with our district's goals for this project. While we do not currently utilize the firewall security features of the FortiGate 601F units, having them act as controllers at each school allows us to better segment our network and element confined to their respective schools' networks. The Extreme products proposed by CDW do not provide this critical functionality and, therefore, cannot be considered equivalent.
