EXPULSION HEARING

 Rosenwald High School student – E.M. Case #1819011

Neither the student nor his representatives were present for the hearing. Attorney Harrison stated that the student's parent(s) had submitted a signed waiver waiving their right to a hearing before the School Board on the Superintendent's recommendation for expulsion of the student and agreed that the School Board enter a Final Order of Expulsion under the terms recommended by the Superintendent as stated in the Superintendent's Notice of Recommended Expulsion and Notice of Hearing. The student is charged with Off Campus Felony Charges.

Attorney Franklin Harrison recommended that the School Board vote on accepting the signed waiver at the School Board Meeting.

Motion by Register, seconded by Neves, to accept the Waiver and the Superintendent's recommendation (that the student be expelled for the remainder of the 2018-19 school year, including summer school, and all of the 2019-2020 school year, including summer school, and not be offered alternative placement during the expulsion period). Motion was unanimously approved.

A. Proposed Geographical Zones 2019-2020 (SMF #17)

The Superintendent explained that these proposed zones have been advertised over 30 days. All schools will be under capacity so School Choice will be open for all schools. Chapman stated she visited Oakland Terrace Elementary School and the Oscar Patterson Elementary School students currently attending Parker Elementary School. She would like to remind everyone that this community has been hit the hardest with closures and would like rebuilding to begin at Oscar Patterson Elementary School. She would like to see a "fun day" to assist the transition of the students to new schools. The Superintendent assured everyone that the students can remain at their current school without filling out a School Choice form. Register feels that the teachers are doing a great job to assist the students. Moss questioned if teachers will be let go and Baker responded that many will leave through attrition and the others will voluntarily transfer to where the students are attending.

The following member from the public addressed Superintendent Husfelt and the School Board Members:

Greg Dossie asked if another school will need to be closed. The Superintendent stated he is not making any additional recommendations.

James Barker felt that grades 6-12 at Rutherford High School is not a good solution. He asked if the District could move the 6-8 grades to Oscar Patterson Elementary temporarily.

Michael Grady Sr: feels that the Glenwood community has bared the brunt of school closures through the years and wonders if any other options are viable.

Greg Dossie spoke about the 1988 Consent Decree.

Franklin Harrison addressed the Consent Degree and rezoning and said that the School Board should focus on making sure that all the schools have a good average of minorities and non-minorities to achieve unitary status. The current rezoning occurred due to a catastrophic event and the District did not have enough time to review the racial composition (nor knew who resided where) but definitely will in future rezoning.

Littleton concurred with Harrison and feels the district must reach unitary status so that all schools reflect the demographics of Bay District Schools.

Motion by Littleton, seconded by Register, to approve the advertised 2019-2020 Proposed Geographical Zones. Motion unanimously approved.

At 2:37 p.m., Chairman Moss directed the School Board back to Organizational Reports.
