# MINUTES BAY DISTRICT SCHOOL BOARD MEETING March 8, 2022

EXPULSION HEARINGS – 10:00 A.M. BOARD MEETING – 1:00 P.M. GINGER LITTLETON BOARDROOM

#### **EXPULSION HEARING**

Present: Chair Pamm Chapman; Vice Chair Jerry Register; School Board Members: Winston Chester, Steve Moss, Brenda Ruthven; Board Attorney Franklin Harrison and Trina Evans, Coordinator of Student Placement Options for Bay District Schools.

Chair Pamm Chapman called the Expulsion Hearing to order at 10:10 a.m.

1) Bozeman Student - R.L. Case No. 2122033

The student and father were present. The parent requested that this matter be held in private. The student was suspended for possession of a weapon on school campus (SESIR). The student and parent did not agree with the recommendation for expulsion. Attorney Harrison requested that the School Board Exhibits #1 through #8 be admitted into evidence. Sworn testimony was given by Ivan Beach, Principal of Deane Bozeman, Christie West, Assistant Principal of Deane Bozeman, the student and father.

The Superintendent recommended that the student be expelled from attending public schools in Bay County, Florida for the remainder of the 2021-2022 school year and all of the 2022-2023 school year, including summer school, and that the student not be offered alternative placement during the expulsion period.

Motion by Moss, seconded by Chester to accept the Superintendent's recommendation for expulsion. Motion passed with four yes and one no by Register.

2) Mosley High Student - D.N. Case No. 2122034

The student and mother were present. The parent requested that this matter be held in private. The student was suspended for drug/sale distribution (SESIR). The student and parent did not agree with the charges. The student and parent did not agree for the recommendation for expulsion. Attorney Harrison

requested that the School Board Exhibits #1 through #8 be admitted into evidence. Sworn testimony was given by Nicole Bailey, Administrative Assistant at Mosley, SRD Officer Brooks, the student and mother.

The Superintendent recommended that the student be expelled from attending public schools in Bay County, Florida for the remainder of the 2021-2022 school year and all of the 2022-2023 school year, including summer school, and that the student not be offered alternative placement during the expulsion period.

Motion by Moss, seconded by Chester to approve Superintendent's recommendation for expulsion. Motion passed unanimously.

3) Merritt Brown Student - C.C. Case No. 2122035

Neither the student nor his representatives were present for the hearing. Attorney Harrison stated that the student's parent(s) had submitted a signed waiver waiving their right to a hearing before the School Board on the Superintendent's recommendation for expulsion of the student and agreed that the School Board enter a Final Order of Expulsion under the terms recommended by the Superintendent as stated in the Superintendent's Notice of Recommended Expulsion and Notice of Hearing. The student is charged with Possession of Weapon on School Campus.

Attorney Franklin Harrison recommended that the School Board vote on accepting the signed waiver.

Motion by Register, seconded by Ruthven, to accept the Superintendent's recommendation that the student be expelled from attending public schools in Bay County, Florida for the remainder of the 2021-2022 school year and all of the 2022-2023 school year, including summer school, and that the student not be offered alternative placement during the expulsion period. Motion passed unanimously.

The expulsion hearing concluded at 12:01 P.M.
